At that time you will provide your credit card number directly to a representative from Brightwater using their 800 number. Alternatively you can arrange a wire transfer. Details about a wire transfer will be available then also.

Cancellation Instructions: If you must cancel because of an emergency, Nadeen will make every effort to find a replacement for you. If a replacement is found, you will be asked to pay a 30 GBP (about \$37) processing fee.

If the virus makes it impossible for our group to travel, we have assurance from BW that our deposit payment of 200 pounds (made in February) will be applied to future travel with Brightwater.
